

ENVIRONMENTAL MANAGEMENT STATEMENT

In all company sectors SENECA favours manufacturing processes and procedures for the valorisation of resources, opting for non-polluting materials, controlled disposal, ecological logistics and the management of the company in terms of maximum energy saving and low environmental impact.

SENECA aims to optimize the use of resources and reduce the impact of its activities on the environment. In this action it takes into account all company resources in the definition and implementation of energy saving activities, waste reduction and territorial protection.

SENECA keeps under control, with the help of a specialized consulting company and a waste disposal company, the management, collection, waste, disposal and recycling activities related to:

- Smoke analysis
- Electronic production waste
- Waste ferrous materials
- Waste Office materials
- Standard waste

It should also be noted that the characteristics of the production and logistics process at the SENECA plants do not determine the use or release of pollutants. Nor are personnel exposed to chemical, physical or biological agents, nor are they in a position to use materials, tools or devices with a high risk to health or to operate in hazardous areas.

Nevertheless, SENECA adopts all the measures and prescriptions provided for by the body of the Directives in force regarding health and safety for: workers, workplaces, equipment, individual protection, manual handling of loads, activities carried out on equipment with video terminals, risks of carcinogens and biological agents.

SENECA also ensures that the products manufactured at its plants and supplied to its customers meet the current regulations in force on environmental safety and health protection of the operators involved.

In particular SENECA:

- It operates in accordance with the criteria required by the RoHS2 Directive (2011/65/EC) and RoHS3 Directive (2015/863/EC) of the European Union, as it applies restrictions to certain hazardous substances in the electrical and electronic equipment supplied.
- In accordance with the EC Regulation n. 1907/2006 (REACH Regulation) and the list of hazardous substances registered by ECHA (European Chemicals Agency), the products manufactured by SENECA do not release, under normal or reasonably foreseeable conditions of use, any hazardous substance also declares that in their products are totally absent substances containing Asbestos.
